**REFERENCE: B008-23 Anthracite Filter Media for Water Treatment Plant II**

This Addendum forms part of the contract and clarifies, corrects or modifies original bid document.

**Question 1:** Will you be able to unload either a flatbed truck or a van closed truck?

**Answer 1:** Deliveries will be accepted only on a flatbed trucks.

**Question 2:** Our company does not unload material at the jobsite, does the City have equipment to unload pallets?

**Answer 2:** BPUB does have equipment to unload pallets.

**Question 3:** Is this bid for a supply/delivery only? There is no service requirement, correct?

**Answer 3:** The purchase of anthracite filter media is for one-time supply and delivery and no service requirement.

**Question 4:** Can you confirm the packaging since the specs from the website and on page 8 says supply by the tote (2,000 lb. bulk bags) and on page 9 it says supply by 1 ft3 bags.

**Answer 4:** Material will be packaged in one cubic foot polypropylene or paper bags Anthracite-50 lbs. each and palletized.

**Question 5:** Name of incumbent/last provider.

**Answer 5:** Leopold / Xylem Water Solutions was the last provider for BPUB.

**Question 6:** May you provide the last Bid tab.

**Answer 6:** Bid tab is no longer available.

**Question 7:** Can you please provide Minimum/Maximum order quantity? Shipping/freight costs are variable based on the quantity, so we need to have an order quantity in order to provide a fixed bid.

**Answer 7:** Maximum order quantity is 1,800 cubic feet.

**Question 8:** Can you accept delivery in a box van or do you require flatbed? (box van generally only works if you have a loading dock and depends on order quantity).

**Answer 8:** A flatbed is required.

**Question 9:** Can you please confirm the City is responsible for unloading at your facility?

**Answer 9:** BPUB staff will unload the product.
