



# BPUB Attic/ Ceiling Insulation Rebate Application



## Rebate Information and Guidelines:

**A credit rebate is available to all BPUB Electric Residential customers when they buy and install qualifying attic/ ceiling insulation. Please direct all questions to 956-983-6282 or E-mail [GoGreenRebate@brownsville-pub.com](mailto:GoGreenRebate@brownsville-pub.com).**

- Applications are subject to verification. If the verification cannot be completed, the rebate will not be paid.
- Address of account must match address of installation.
- Applications must be completed and submitted within 30 days of installation. Please allow 3-6 weeks after receipt of all documentation for the rebate to be issued.
- Rebate recipient must be a customer of BPUB electric services.
- Rebate Amount = (\$0.01) x (square foot of insulated space) x (R-Value added); up to \$500.
- Attic insulation must be installed between conditioned and unconditioned areas to qualify; garages and other non-conditioned areas do not qualify.
- Final insulation must be at least R-38 or R-23 for spray foam.
- Polyurethane spray foam (closed-cell) applications shall be a minimum of 5 inches in thickness when applied to interior roof deck.
- Polyisocyanurate spray foam (open-cell) applications shall be a minimum of 5.5 inches in thickness when applied to interior roof deck.
- The current insulation level of each home will be determined and documented by the insulation installer. Degradation due to age and density of the existing insulation should be taken into account.
- Square footage measurements will be verified against Cameron County property tax records showing floor plan of home.
- An itemized and dated invoice from the contractor or retailer including manufacturer, type, R-Value, number of bags installed and square footage along with application is required.
- Program may be discontinued by BPUB at anytime. Rebates are contingent upon fund availability.
- Only one application per fiscal year (October 1 through September 30) will be accepted per customer per program.
