





What is Causing the Damage?

BTX Fiber, LLC contractors are boring underground in the right-of-way, and their equipment is striking existing underground facilities

- Water pipes
- Sewer pipes
- Electrical lines
- Natural gas lines
- Fiber cables
- Telephone cables

Strikes damage infrastructure, cause outages for our customers, and can decrease the useful life of the infrastructure

Governing Documents

- •Fiber Network Coordination Agreement by and among City of Brownsville, Texas, and Brownsville Public Utilities Board, and LIT Texas, LLC, and its affiliate BTX Fiber, LLC, dated as of July 20, 2022
 - Under Section 3 of the Agreement, BPUB agrees to cooperate with the City in providing access and use of certain BPUB-owned real estate and utility easements for constructing the new Fiber Network Work
 - Does not contain terms as to construction damages nor remedies but does reference the Engineer, Procurement, and Construction Contract
- •Engineer, Procurement, and Construction Contract for Fiber Middle Mile Network between the City of Brownsville, Texas, as owner, and LIT Texas, LLC, effectively dated July 20, 2022
 - Under Section 4.04 A.2.d of the General Conditions (Exhibit D), <u>LIT is responsible for the safety and protection of all such Underground Facilities and repairing any damage thereto resulting from the Work</u>
 - Under Section 6.21 B of the General Conditions (Exhibit D), <u>LIT indemnifies the City against all loss</u>, damage, or destruction of property of the City

Underground Facility Damage Prevention and Safety Act

TEXAS UTILITIES CODE TITLE 5. PROVISIONS AFFECTING THE OPERATION OF UTILITY FACILITIES

CHAPTER 251. UNDERGROUND FACILITY DAMAGE PREVENTION AND SAFETY

- Created the Texas One-Call Law "Texas 811"
- Provides the requirements relating to:
 - Class A underground facility operator
 - Excavator
 - Texas Underground Facility Notification Corporation





Process Flow for Underground Facilities Location





BPUB provides to 811 updated electronic maps of underground facilities at least every three months



BPUB contracts with USIC to provide location services when contractors contact 811 prior to excavating



BTX Fiber contacts 811 with location of excavations at least 48 hours before excavating



- > 811 provides maps to USIC
- ➤ 811 contacts USIC to mark underground facilities



USIC visits the excavation site and marks with paint and flags the underground facilities using maps, GPS, and detectors

Additional Mitigation Efforts

- •BPUB provides 811 updated maps of underground facilities every two weeks
- •BPUB contacted USIC to ensure they had the most recent BPUB underground facilities maps
- •BPUB, COB, USIC, and BTX Fiber hold weekly discussions regarding project issues
- •BTX Fiber provides BPUB with a 14-day outlook, and BPUB provides updated maps to BTX for the locations to augment USIC markings
- •BPUB responds to BTX Fiber requests to help locate underground facilities
- •BPUB responds immediately when underground facilities are struck to minimize damage and disruption of service to customers
- •BTX Fiber has terminated contracting partners for failing to follow proper procedures while performing work

⁽³⁾ Costs of repairs include labor, materials, equipment, asphalt paving, concrete paving, and water losses. BPUB is currently updating all costs.

Invoice Chronology

- July 22, 2022: Agreement for Fiber Middle Mile Network Project (FMMNP)
- March 28, 2023: BTX Fiber makes the first strike on BPUB underground facilities
- •July 21, 2023: Meeting held with BPUB, BTX, and COB, and BPUB presented information to BTX Fiber on 17 strikes on underground facilities with an estimated cost of \$257,317
- October 4, 2023: Brownsville City Manager officially requests BPUB send all outstanding invoices related to the FMMNP
- October 9, 2023: BPUB submits invoice for \$892,323 to LIT Texas,
 LLC with notices as required per Agreement
- October 10, 2023: Mr. Brian Snider, CEO of LIT Communities Broadband, Inc., acknowledged receipt of invoice

11/13/2023

- October 17, 2023: BPUB and COB held a meeting to discuss the invoice and coordination measures for the FMMNP
- November 8, 2023: BPUB informed LIT Texas, LLC that the October 9th invoice was voided and would be revised and resubmitted

Fiber Network Installation Summary of Damages and Request for Payment pursuant to the Fiber Network Coordination Agreement by and among City of Brownsville, Texas, and Brownsville Public Utilities Board, and LIT Texas, LLC, and its affiliate BTX Fiber, LLC dated as of July 20, 2022 (the "Agreement")

Dcar LIT Texas, LLC and LIT Fiber

As requested in the City of Browsville letter dated October 4, 2023, the purpose of this letter is to provide a summary of Brownsville Public Utilities Board's ("BPUB") property and utility damages caused by LIT Texts, LLC and its affiliates (each and collevitively, "LIT") during the performance of the construction and installation of the new Fiber Middle Mile Fiber Network infrastructure to provide eable, broadband and fiber facilities and interconnects to the City of Brownsville residents and community (the "Fiber Network Work") under the terms and conditions of the Agreement.

During construction activities for the Fiber Network Work within the BPUB catenents, LTT caused substantial damages, water losses, and other tuility outages to existing BPUB property and utilities serving the community. The damages occurred between March 28, 2023 and September 27, 2023. When LTT caused damages to BPUB's utilities and infrastructure, LTT contacted BPUB to repair the damages.

BPUB has notified the City of Brownsville ("City") Engineering & Public Works Director Doroteo Garcia of each of these occurrences and the damages and expenses incurred as a result.

At this time, BPUB requests reimbursement and payment to BPUB in the amount of \$892,323 for such damages and repairs to be paid within the 30 days of the date of this letter.

Under Section 3 of the Agreement, BPUB agreed to cooperate with the City in providing access and use of certain BPUB owned real estate and utility easements for the construction of the New Fiber Network Work. As consideration to BPUB for cooperating with the Fiber Network Work.





U.S. Combined Ownership at Amistad/Falcon




Drought Response Stages

Stage 2 – Restrictions


Stage 3 – Surcharges

Stage 4 – Rationing






Valid for November 2023 Released October 31, 2023

Bottom Lines

- Sufficient inflows from Mexican Reservoirs serving the Lower Rio Grande Watershed are unlikely during the "cool" season.
- Combined share of water in Amistad and Falcon Reservoirs predicted to continue at or near Stage 2 triggers through winter.
- National Weather Service (NWS)
 - Drought/Dryness should remain but improve. (Soil moisture only)
 - ✓ Cold Fronts and Cold Snaps, likely to favor occasional, rather than frequent.
 - □ Sharp Temperature changes 30 to 60 degrees (will cause more light rain/drizzle in our area)





Utility Locator Services – USIC

- The Texas Underground Facility Damage Prevention and Safety Act requires BPUB to mark the approximate location of its underground facilities for excavators.
- BPUB, like most utilities, outsources this requirement.
- USIC has provided services to BPUB since at least 2010
- Formal RFP was issued in 2018, and USIC was the sole proposer
- BPUB used a State BuyBoard to contract with USIC in August 2021
 - Base year: August 2021 to August 2022
 - Option 2nd year: August 2022 to August 2023 (exercised June 2022)
 - Added \$455,222 in contract funding
 - Option 3rd year: August 2023 to August 2024 (not exercised)



Utility Locator Services – USIC

- Amendment 1: Approved on September 1, 2023
 - Extended period of performance to November 30, 2023
 - Allowed BPUB to issue an RFP for locator services to ensure the best prices
 - Added \$113,805 in contract funding
 - Increased contract total funding to \$569,027
- Amendment 2: Ratification of increased funding for the USIC contract by \$50,000
 - o Greater than expected requests for locator services between September and November 2023
 - BPUB executed a contract amendment to avoid a lapse in required services
 - Increases contract total funding to \$619,027
- Amendment 3: Request to extend the period of performance and increase funding
 - o Extend period of performance to February 29, 2024
 - Add \$150,000 in contract funding
 - Increases contract total funding to \$769,027



RFP for Utility Locator Services

- BPUB issued RFP for locator services in July 2023
 - USIC was the sole respondent
- Executive team recommended, and Board approved rejection of bid in October 2023
- Revised RFP was advertised on October 24, 2023, with bids due November 15, 2023
 - Base year period of performance expanded to two years with two one-year options to encourage more bids
 - BPUB contacted 14 providers of locator services to gain the attention of the RFP
