



BPUB ENERGY STAR Duct Performance Rebate Application

Rebate Information and Guidelines:

A credit rebate is available to all BPUB Electric Residential customers when they repair or replace duct work to improve air flow performance. Please direct all questions to 956-983-6282 or E-mail GoGreenRebate@brownsville-pub.com.

- Applications are subject to verification. If the verification cannot be completed, the rebate will not be paid
- Address of account must match address of installation
- Applications must be completed and submitted within 30 days of installation of unit(s). Please allow 3-6 weeks after receipt of all documentation for the rebate to be issued
- Rebate recipient must be a customer of BPUB electric services
- Replacement of existing duct work or the repair and improvement of existing duct work; for retrofit only
- Work must be done by a licensed TAEL contractor
- Must have duct testing done to show energy efficiency improvements of system.
- Testing must be done by a HERS Certified Rater; contact BPUB prior to any work
- First duct blaster test to establish base leakage; second test to establish results; all results must will be sent to BPUB
- Pretesting must show 20% or more leakage in the duct system
- Post-testing of the repairs and/or replacement must show 10% or less leakage in the duct system
- BPUB will pay for 50% of the cost of testing the duct system up to \$125/system
- A rebate of 25% of cost up to \$500/ system
- Only one application per fiscal year (October 1 through September 30) will be accepted per customer per program.
