Question 1: Would BPUB consider upgrading to the latest version of Cityworks (15.8.6)?

Answer 1: Yes, BPUB would consider upgrading to the latest version of Cityworks.

Question 2: Is BPUB using any Cityworks JavaScript or XML customizations? If so, please provide descriptions.

Answer 2: Yes, BPUB is using both JavaScript and XML customizations in Cityworks. We have created different XML for Service Request layouts based on Employee Group. There are also JavaScript modifications done in the layouts to create hyperlinks.

Question 3: Is BPUB using Crystal reports with Cityworks? If so, please provide sample reports.

Answer 3: Yes, BPUB is using Crystal Reports with Cityworks. There are currently ~110 reports created in-house. Attached is one sample.

Question 4: Please describe the Customer Trouble Reporting/Cityworks integration.

Answer 4: We have an integration in-house (Online Assist) and with Milsoft (IVR) that uses Cityworks web services in order for the customer to report any issues through Online App or telephone. Each of these actions generate a Cityworks Service Request that is recorded for BPUB Dispatch to take action.

Question 5: Please describe the Cityworks/Freeance integration.

Answer 5: The Freeance application is used as provided (out of the box), there are no customizations or custom components. Setup is done through the Freeance configuration site which allows us to connect to our GIS services and the Cityworks database and configure user groups for the different areas.




