# ELECTRIC UTILITIES SESSION OVERVIEW

## Entering the session anticipating electric legislation centered on the following:

- How would the grid incorporate the increased demand for large loads, specifically data centers developing AI?
- Focusing on grid reliability, including specific attention given to recent wildfires and wind storm driven outages.
- Continuing discussion of reviewing the significant surge of new renewable energy resources and their impact on the grid (solar, wind and battery).
- Continuing conversation on generation siting and transmission build out.
- Renewed attention on policies to achieve a greater amount of dispatchable generation within a deregulated market and exploring research and development for nuclear power and furthering incentives for fossil fuel generation and lessening renewable generation.
- Key players in these policy discussions included Sen. Schwertner ( Chairman of Senate Business and Commerce), Rep. Ken King (Chairman of House State Affairs), Sen. Phil King, Rep. Drew Darby, Governor's and Lt. Governor's office, ERCOT and PUCT.



# KEY ELECTRIC BILLS PASSED

- SB 6 (Sen. King)- Sets forth a regulatory process for interconnection and service to large loads. Includes financial requirements, disclosures of developer's intentions, expedites interconnection process, addresses co-location with dedicated generation resources, establishes new review of cost allocation methodology for transmission charges.
- SB 75 (Sen. Hall) – Creates a Texas Grid Security Commission tasked to evaluating Grid resiliency in addition to the activities of local government and private infrastructure services and to provide a report to the Legislature by 12/01/2026, with a comprehensive plan protecting critical infrastructure.
- HB 14 (Rep. Harris) - Establishes the Texas Advanced Nuclear Energy Office within the Governor's office to support development of advanced nuclear reactors (ANRs) in Texas and provides significant grants.
- SB 2268 (Sen. Schwertner)- Gives PUCT additional authorities to make Texas Energy Fund Loans and disbursements after 12/31/2025. TEF also received an additional \$5Billion Appropriations from the State's general revenue funds to continue administering the program.



# KEY ELECTRIC BILLS PASSED

- SB 1202 (Rep. King ) - Allows authorized third parties to provide development inspections of home back up power installations connected at 600 volts or less. Provides options to avoid delays in municipal permitting.
- SB 1252(Rep. King) - Prohibits municipality from adopting or enforcing amendment to the National Electric Code that would regulate the inspection or installation of a residential energy backup system that provides no more than 50kw of electricity to the residence or has a storage capacity of no more than 100 kwh. Note: MOUs may still regulate the installation or inspection of these systems.
- SB 1789 (Sen. Schwertner) - Requires the PUC to adopt standards for transmission and distribution pole structural integrity and requires MOUs to file annual reports of inspection and remediation under their own standards.
- HB 144 (Rep. King) - Comparable to SB 1789 requiring each distribution utility to develop a plan for the management and inspection of their system distribution poles
- HB 1991 (Rep. Guillen) - Requiring municipalities to publish terms and conditions of utility charges on both the utility system's and the municipality's websites.



# KEY ELECTRIC BILLS PASSED

- HB 3809 (Rep. Darby) - Battery energy storage facility decommissioning requirements modeled on the applicable wind and solar decommissioning statutes.
- HB 3824 (Rep. King )- Battery energy storage system fire safety legislation based on national standards with rules developed by the Texas Department of Insurance. Includes provision for fire safety inspection reports and emergency operations plan and annual training for local first responders.
- HB 1606 (Rep. Metcalf ) - Requires electric utilities, munis and coops to adopt a procedure for customers to request vegetation management near a transmission or distribution line.
- HB 1584 (Rep. Hull ) - Requires electric utility to maintain a list of priority facilities in addition to medical facilities that are in its service area that are crucial for the protection or maintenance of public safety.
- SB 482 (Sen. Alvarado) - Provides for a 3<sup>rd</sup> degree felony if a person assaults an employee or agent of a utility performing a duty within the scope of their employment or agency in an area that is the subject of a declaration of a state of disaster or emergency.
- HB 3092(Rep. Gerdes )-Increases exemption for requiring a CCN for a transmission line connecting a lad-serving substation or metering point to the transmission facilities from three to five miles.





# WATER UTILITIES SESSION OVERVIEW

**Entering the session anticipating water related legislation centered on water infrastructure and the need to improve it through planning and funding, all in recognition of severe water shortages, drought and historic reservoir low levels:**

- Significant efforts were made to examine the state's water needs and to recognize the necessity of updates to the State Water Plan, including long range funding.
- Discussions were had regarding the relationship of state and local entities to planning and funding local water projects, including the implementation of direct grants from state appropriations and a review of the Texas Water Development Board's grant process.
- Policy makers showed a favored interest to regional projects and joint planning/agreements between local entities.
- Key players in these policy discussions included Sen. Charles Perry (Chairman of Senate Ag and Rural Affairs) and Rep. Cody Harris, as well as Governor and Lt. Gov. staff.



# KEY WATER AND ENVIRONMENTAL BILLS PASSED

- HJR 7/SB 7 (Rep. Harris / Sen. Perry) - Creation of Texas Water Fund subject to approval of voters in November, dedicating \$1Billion to water infrastructure.
- SB 1261 (Sen. Perry) - Provides for optional financing tools to enable affordable implementation of large regional water supply projects included in the State Water Plan.
- SB 480 (Sen. Perry) - Provides for water planning interlocal agreements with certain governmental entities to participate in water research and planning activities.
- SB 6 (Sen. King) - Aids Laredo desalination project providing electric generation built to support water desalination facility in Laredo may sell excess electricity to the grid and use revenues for water service corporation operational expenses (originally was HB 3896 but later amended to SB 6).
- SB 1169 (Sen. Hinojosa w/ Rep Guillen sponsor) – Allows public entities to operate jointly as “public utility authority” to finance water & sewer service project.
- HB 29 (Rep. Gerdes) - Water audit validation (requires water loss mitigation plan) for municipally owned utility that has more than 150,000 service connections.
- SB 14 (Sen. Perry)(2nd called session) – Requires political subdivision establish tax credit procedures for builder or developer who utilizes or installs water infrastructure resulting in water reuse/conservation/savings.



# KEY WATER AND ENVIRONMENTAL BILLS PASSED

- HB 500 (Rep. Bonnen) – Supplemental state budget. BPUB received \$47,258,000 of general revenue grants for two projects:
  - \$34,558,000 for the Banco Morales Reservoir surplus water impound
  - \$12,700,000 for City of Brownsville Direct Potable Reuse Project
- Senate Concurrent Resolution 13 (Sen. Hinojosa) – Respectfully urges the US Department of State & the US International Boundary & Water Commission to take appropriate action to ensure that Mexico complies with the 1944 Water Treaty regarding shared water resources, and to take all necessary steps to make deliveries.

# UPCOMING ISSUES

## ENERGY

- DRRS protocol development (fall 2025) and stakeholder approval (2026)
- First ERCOT reliability assessment (2026) and potential market design changes
- SB 6 implementation and large load approval processes
- 765-kV STEP buildout progress and additional segments
- Generation interconnection queue evolution — which projects achieve synchronization?
- VPP program expansion and residential demand response scaling
- Co-location regulatory clarity and project pipeline development
- Nuclear initiatives gaining traction (SMRs, existing plant expansions)
- Energy storage deployment (180 GW in the interconnection queue)
- Extreme weather responses and grid resilience investments
- Rising energy costs

## WATER

- Impact of high-capacity and large volume groundwater production will continue to be studied & we anticipate legislation next session to address groundwater production, potentially statewide based on the development plans in the Neches & Trinity Valleys Groundwater Conservation District.



# LOOKING AHEAD

- Not a likelihood for additional special legislative sessions
- Senate and House will issue Interim charges 4th quarter with hearings until late 2026.
- November 4, 2025 constitutional amendment election (see next slide) as well as scattered special elections across state.
- Primary election March 3, 2026. More than 2 dozen lawmakers decided not to return for the 90<sup>th</sup> session, so many (but not all) of their seats will be decided in this primary election. All major statewide legislative leaders will also be on the primary ballot, including the Governor, Lt. Gov., Attorney General, Comptroller, RRC Chairman, and AG Commissioner.
- Potential primary election campaign issues:
  - Rising energy cost
  - Gov. Abbott: “Local governments are hiking your property taxes incessantly,” he said. “It’s time to drive a stake through the heart of the ability of local property tax hikes for good.”
- Continued legal review of mid decennial Congressional redistricting.

# Current Policy

---


Last revised and approved by the Board on October 10, 2005.

Establishes the general hours of work and how overtime and call-out are paid.




# Policy Updates

---

- Reformatted and revised to align with current policy structure
  - Limited work hours to 14 consecutive hours with 8 hours of rest in between shifts
  - General Manager & CEO can authorize additional work hours for an emergency or to maintain uninterrupted services
  - On-call status includes both primary and secondary on-call work
- 

# Policy Updates

---

- Limited on-call to 10 consecutive days with a minimum of 3 days on-call rest period
  - Employees on a paid leave status cannot be placed in on-call status until they have returned to work
  - Added clarity specific to non-compliance and uniformity
-

# Current Policy

---

- Last revised and approved by the Board on October 10, 2005.
- Provides for educational assistance for BPUB employees obtaining an undergraduate degree.

# Policy Changes

---

## CURRENT

- Educational Assistance Program
- Full-time employees
- Undergraduate
- Must complete initial probationary period
- 60% Reimbursement\*

## PROPOSED

- Tuition Assistance
- Full-time and part-time employees
- Associate's, Bachelor's, Master's
- Employees eligible day one
- Stratified Reimbursement\*
  - A = 100%
  - A & B = 80%
  - A, B & C = 60%

*\*Based on the current UTRGV tuition and fees plan*

# Policy Changes

---

## CURRENT

- Employee repays BPUB if they separate from BPUB within 24 months of graduation

## PROPOSED

- Employee repays BPUB if they separate from BPUB within 24 months of graduation
- Upon completion of a Bachelor's or Master's degree, the employee will receive a 1% annual increase for 3 consecutive years
