



WaterSense High-Efficiency Toilet Rebate Application

ELIGIBILITY

1. Applications are subject to verification. The rebate will not be paid if the verification cannot be completed.
2. The installation address must match the address on the active BPUB water services account.
3. The rebate recipient (tenant or property owner) must be a BPUB customer. Property ownership will be verified using county records.
4. There is a limit of three High-Efficiency Toilets per address.
5. BPUB may discontinue the program at any time. Rebates are contingent upon fund availability.

PROGRAM TERMS AND CONDITIONS

1. The High-Efficiency Toilet must be Water Sense® certified. Please confirm with the seller before purchasing.
2. Your account will be credited up to \$100.00 or the cost of the toilet (If less) per High-Efficiency Toilet installed.
3. A copy of the purchase receipt or sales invoice is required.

- 2. Provide a copy of the paid invoice/receipt.
